Lorne Bruce, Free Books for All: The Public Library Movement in Ontario, 1850-1930 (Toronto and Oxford: Dundurn 1994).

THE RISE of the free public library movement in the late 19th century grew out of the decline of the Mechanics' Institutes and the rise of the common school. This account explores the successful institutionalization of the free library movement in the 1880-1930 years, chronicling the individuals and groups that promoted ideas given philanthropic backing by Carnegie.

Michael Twaddle, ed., The Wages of Slavery: From Chattel Slavery to Wage Labour in Africa, the Caribbean and England (London: Frank Cass 1993).

THE ESSAYS in this volume explore the transition from chattel slavery to wage labour on three continents, discussing work practices and forms of payment before and after emancipation.

David F. Noble, Progress Without People: New Technology, Unemployment, and the Message of Resistance (Toronto: Between the Lines 1995).

NOBLE EXPLORES the tremendous costs of the purposively "deworking" of contemporary economies, pointing to the necessity of resisting corporate agendas

whose reification of progress minimizes the importance of people.

Sandord M. Jacoby, ed., The Workers of Nations: Industrial Relations in a Global Economy (New York: Oxford University Press 1995).

A SERIES of essays that explore the impact of the global economy on work-places, class conflict, and industrial relations policy.

Jim Fyrth, ed., Labour's High Noon: The Government and the Economy, 1945-1951 (London: Lawrence and Wishart 1993).

SIXTEEN commentators offer perspectives on the Labour Party's years of greatest potential, providing judgements on nationalization and economic planning, foreign policy, race and empire, women's employment, the unions, the Scottish question, education, and other issues.

Stephen E. Hanson and Willfried Spohn, eds., Can Europe Work? Germany and the Reconstruction of Postcommunist Societies (Seattle and London: University of Washington Press 1995).

David L. Hoffmann, Peasant Metropolis: Social Identities in Moscow, 1929-1941 (Ithaca and London: Cornell University Press 1994).

HOFFMAN EXPLORES the mass migration of Soviet peasants to the cities over the course of the 1930s, examining how this demographic movement changed the nature of urban life and contributed to the making of an authoritarian welfare state.

John Mathews, Catching the Wave: Workplace Reform in Australia (Ithaca, NY: ILR Press 1994).

MATHEWS introduces a North American audience to the nature of Australia's restructured economy by laying stress on the reforms achieved through innovative labour relations.

Gilbert M. Joseph and Daniel Nugent, eds., Everyday Forms of State Formation: Revolution and Negotiation of Rule in Modern Mexico (Durham and London: Duke University Press 1994).

INTRODUCED by James C. Scott, this collection of essays looks at state formation and everyday life with tantalizing glimpses at literacy, the revolutionary left, agrarian reform, and other features of the regime of 19th and 20th century Mexico.
