## NOTES ON CONTRIBUTORS

**Mounia Benalil** est chercheuse postdoctorale au département de langue et de littérature françaises de l'Université McGill. Ses recherches portent sur les visions, représentations et images de l'Orient dans les littératures francophones en général et la littérature québécoise en particulier. Elle est l'auteure de plusieurs articles parus dans des revues savantes au Canada et à l'étranger.
