VITTORIO DE VECCHI
1941-1983

Historians of Canadian science lost one of their younger colleagues with the death, in June, of Vittorio De Vecchi, in Italy. Dr De Vecchi was a pioneer in the study of the historical connections between science and the Canadian government. His earlier studies were technical, but in the early 1970s he came to the Institute for History and Philosophy of Science and Technology at the University of Toronto. His doctoral dissertation, 'Science and Government in Nineteenth Century Canada' (1978) was a seminal work which has led to a number of studies of this much-neglected area. He was particularly interested in Canadian government initiatives in agricultural research. Dr De Vecchi's interests in science and government led him to work at the University of Sussex after graduation. In recent years he was teaching at the University of Pavia. As part of the 1982 centennial of the first meeting of the British Association in Canada, De Vecchi persuaded the Royal Society of Canada to organize a conference at the British Association's meeting in York, England. He leaves his wife, Ann Hopper De Vecchi, and a son Thomas.

AECL HISTORY

The following notice has been sent to Deans of Arts and Sciences throughout Canada:

THE THIRD KINGSTON CONFERENCE

The programme for the Third Kingston Conference on the history of Canadian science, technology and medicine is now finalized. For those who have not received the conference brochure, we provide here the basic information and schedule of events.

Accommodation and Meals: participants may elect to stay at the Donald Gordon Centre. A single room with shared facility and all meals is \$67.20 a day, payable at the Centre. The Association banquet is included in the price. Those wishing to stay elsewhere may do so and buy meal tickets at the Centre should they desire to dine with the other conferees. There is a limited number of places and will be reserved on a first-come, first-served basis. No deposit is required but a place should be reserved early. Overflow will be accommodated nearby at the same price, with meals at the Centre.

Pre-registration fees: members of the Association should pay \$25.00, students \$15.00, and non-members \$35.00. The deadline for pre-registration is 30 September 1983.
