**PETER CLANCY** is Associate Professor of Political Science at St. Francis Xavier University. He has published a number of articles which reflect his research interest in comparative forest policy, the most recent being, "Formulating Standards for Sustainable Forest Management in Canada", (with Anders Sandberg), which appeared in Business Strategy and the Environment (1997). ANDERS **SANDBERG** is Associate Professor in the Faculty of Environmental Studies at York University. His co-edited (with Sverker Sörlin) book, Sustainability - The Challenge: People, Power, and The Environment will be published in the winter of 1998 by Black Rose Books. Since receiving his Ph.D. in history from the University of New Brunswick, BILL PARENTEAU has been involved in research which focuses on the political, social and environmental dimension of forest, fish and game resource use in the Atlantic region.
