Gail Cuthbert Brandt is professor of history and Principal of Renison College at the University of Waterloo. She has written a number of articles on the history of women in Canada, and is co-author of *Canadian Women: A History*

Béatrice Craig est professeur d'histoire à l'Université d'Ottawa. Ses recherches portent sur une communauté francophone hors-Québec. Elle a publié des articles dans *Histoire sociale-Social History*, *Revue d'histoire de l'Amérique française*, *Journal of Forest History*, de mêmes que dans d'autres revues spécialisées.

Elizabeth Ewan is an associate professor of history at the University of Guelph and member of the Scottish Studies programme. She is author of *Townlife in Fourteenth-century Scotland* (Edinburgh, 1990), and articles on Scottish towns and women. She is preparing a book on women in mediaeval Scotland.

Jack Little is professor of History at Simon Fraser University and author of a number of articles and books on Eastern Townships history. *Crofters and Habitants: Settler Society, Economy, and Culture in a Quebec Township, 1848-1881* (Kingston and Montreal, 1991) won the Canadian Historical Association's Regional History Certificate for Quebec, as well as the Grand Prix Lionel-Groulx offered by l'Institut d'histoire de l'Amérique française.

John Lutz is a doctoral candidate at the University of Ottawa. His dissertation examines the relationship between aboriginal people, the economy and the state in 20th century Canada.

Michael J. Piva is an Associate Professor of History at the University of Ottawa. He has published *The Condition of the Working Class in Toronto, 1921* (1979) and *The Borrowing Process: Public Finance in the Province of Canada, 1840-1867*, (1992), and edited *A History of Ontario: Selected Readings*, (1988) and *The Twentieth Century World: Selected Readings*, (1991).

Barrie M. Ratcliffe est professeur titulaire au Département d'histoire de l'Université Laval. Il a publié ou dirigé, seul ou en collaboration, trois ouvrages.
