## Contributors

**Dr. Lori Chambers** is a Professor in the Department of Women's Studies at Lakehead University where she teaches courses in feminist theory, queer theory, the history of women and the law, critical contemporary legal issues and social activism. Her research interrogates the role of law in maintaining the social and economic inequality of women and their dependent children. She is the author of *Married Women and Property Law in Victorian Ontario* (Toronto: UTP, 1997), and *Misconceptions: Unmarried Motherhood and the Ontario Children of Unmarried Parents Act, 1921-1969* (Toronto: UTP, 2007) as well as numerous articles in legal and historical journals.

**Dennis Duffy** is presently at work on pioneering Ontario psychiatrist C.K. Clarke's study of a criminal psychopath who came his way in Kingston's Rockwood asylum in the late 1800s.

**Keith Fleming** is an Associate Professor in the Department of History at the University of Western Ontario with research and teaching interests in North American business history and Canadian political history. He is the author of "the world is our parish": The Public Life and Political Ideals of John King Gordon, 1900-1989 (forthcoming, University of Toronto Press).

**Kirk W. Goodle**t grew up in Mimico, Ontario and is a PhD candidate in the Department of History at the University of Waterloo. He also works at the Laurier Centre for Military and Strategic Disarmament Studies (LCMSDS). His research focuses on modern Europe.

William Hamilton is a SSHRC funded PhD candidate studying history at Concordia University. With a focus on oral history, he examines public history in Northern Ontario. In particular, he studies how this region—once referred to as 'New Ontario' on account of its natural riches—is presenting stories about its industrial past now that many the mines and mills that drove Euro-Canadian settlement northwards are closing.

**Brent Scollie** is a graduate of Queen's University, Kingston, where he shared the first year history prize with George Raudzens, and also of the University of Toronto. He has contributed several biographies to the *Dictionary of Canadian Biography* and many articles to the Thunder Bay Historical Museum Society *Papers & Records*. His interest in history was sparked by the late Dr. Elizabeth Arthur, then head of the history department at Fort William Collegiate Institute. After several years teaching French and English, he joined the federal public service from which he retired in 1997. He has lived in Ottawa since 1973 where he enjoys being able to speak French.

**John Steckley** has been teaching in Liberal Arts and Sciences at Humber College since 1983. Although he has written textbooks in sociology, physical anthropology and Native Studies, his area of special expertise is in the Huron/Wendat language, culture and history. Five of his books are studies of the language.
