Notes on Contributors

Gail Avrith-Wakeam received her PhD from the University of Pennsylvania, subsequently teaching at York University and the University of Guelph. Her primary interest lies in the history of anthropology during the 19th Century. She recently co-authored (with Suzanne Zeller) the entry on George Mercer Dawson in the *Dictionary of Canadian Biography* (Toronto: University of Toronto Press, 1994).

David Branagan was educated at the University of Sydney, where he took his PhD in 1963, and where he taught – in the Department of Geology and Geophysics – until 1989. He is currently President of the International Commission for the History of Geological Sciences, and is studying aspects of nineteenth-century Australasian science.

Nancy Christie received her PhD from the University of Sydney in 1987 for her comparative study of Darwinism and the writing of history in Canada and Australia. She has published widely in the history of science and religion in Canada, and is the co-author, with Michael Gauvreau, of 'A Full-Orbed Christianity:' The Protestant Churches, the Social Sciences and the Welfare State in Canada.

Rod Home studied physics and then history and philosophy of science at the University of Melbourne before completing a PhD in history and philosophy of science at Indiana University. he has been Professor of History and Philosophy of Science at the University of Melbourne since 1975. He has published extensively on the history of eighteenth-century physics and, more recently, on the history of science in Australia. He is editor of *Historical Records of Australian Science* and is currently preparing a history of the Australian physics community to 1945.

James P. Hull was educated at York University, where he took his PhD in 1986. He teaches the history of science at Okanagan University College in Kelowna, British Columbia. His most recent paper, 'The State and the Technological Integration of the North American Pulp and Paper Industry,' appeared in *Essays in Economic and Business History*.

Richard Jarrell holds a PhD from the University of Tornto and is Professor of Science Studies at Atkinson College, York University. His current research centres upon the history of science education in Canadian universities and radio astronomy. He and Yves Gingras edited *Building Canadian Science: The Role* of the National Research Council (Thornhill: Scientia Press, 1991).

Roy MacLeod was educated at Harvard, the LSE, and Cambridge. He is currently Professor of (Modern) History at the University of Sydney. He has written extensively in the history of science, technology, and medicine, and on Australian medical and military history. In 1988, he edited *The Commonwealth* of Science: ANZAAS and the Scientific Enterprise in Australasia, 1888-1988 (Melbourne: Oxford University Press, 1988), and has has recently completed a study of the transmission of British science to Australia – Imperial Science under the Southern Cross (Melbourne University Press, forthcoming).

John Mulvaney is Secretary to the Australian Academy of the Humanities. His publications include *The Prehistory of Australia* (London: Thames and Hudson, 1969), *Encounters in Place: Outsiders and Aboriginal Australia*, 1606 - 1985 (St. Lucia, Queensland: University of Queensland Press, 1989), and a number of articles on the history of Australian anthropology. An Emeritus Professor of Prehistory at the Australian National University, he was also the 1984-5 Visiting Professor of Australian Studies at Harvard University.

Ian Rae is a graduate of the University of Melbourne and the Australian National University. A chemist with an extensive research record, he has been at Monash University since the late 1960s, and was appointed Dean of the Faculty of Science in 1990. From this exalted position he writes on the history of chemists, chemistry, and chemical technology in Australia.

Andrew Ross took his BA in the University of Adelaide, and his PhD at the University of New South Wales. His thesis was on munitions production in Australia. He worked for the Department of Defence, and now farms in northern New South Wales.

Suzanne Zeller is an Associate Professor of History at Wilfrid Laurier University, and the author of Inventing Canada: Early Victorian Science and the Idea of a Transcontinental Nation. (Toronto: Toronto University Press, 1987).

David Zimmerman is an Associate Professor in Military History at the University of Victoria, Canada. He took his PhD at the University of New Brunswick in 1988. His publications include *The Great Naval Battle of Ottawa* (Toronto: Toronto University Press, 1989), and *Top Secret Exchange: The Tizard Mission and the Scientific War* (forthcoming)
